## K-9 UNIT

The Gloucester County Sheriff's Office has 10 dogs trained in Explosives Detection, Patrol, Narcotics and Human Scent Tracking. Our K-9's assist with detecting and apprehending fleeing or hidden suspects, high risk motor vehicle stops and searches, and searching for explosives, narcotics, articles and missing persons. Our K-9 Unit also conducts demonstrations.

#### COURTHOUSE SECURITY

Provides security for all Gloucester County Superior Court facilities. Criminal Court, Civil Court and Probation Office.



# **CIVIL PROCESS**

There are many different aspects and responsibilities of this division, although the primary responsibility is the service and enforcement of all Superior Court orders and Subpoenas.

## PATROL UNIT

The Sheriff's Office Provides arrestee transportation services to law enforcement departments within Gloucester County. The Patrol Unit provides 24-hour service, 365 days a year.

#### TRAINING UNIT / BOMB UNIT

The Training Unit is responsible for the initial training of new hires/recruits and continuing education/training for all officers.





### **WARRANTS UNIT**

Locate and apprehend subjects who have outstanding arrest warrants and return them to the jurisdiction of the court.
